

# Youth Justice First Nations Scholarship and Graduate Program

Youth Justice Services

**Far North and North Queensland**



**The First Nations Scholarship and Graduate Program is designed to increase Youth Justice cultural capacity and competence by employing Aboriginal and Torres Strait Islander people.**

**It is a unique response to the extremely high rates of Aboriginal and Torres Strait Islander young people in the youth justice system.**

### **In the first year of the program**

#### **Scholarship**

Recipients of the award will receive financial assistance to complete the final year of their eligible course of study. An amount of up to \$10,000.00 will be funded by the department and administered by the university to pay for study expenses.

#### **Paid placement**

Recipients will have access to up to four weeks of paid placement at a Youth Justice Service Centre during the year of scholarship. The placement will provide an introduction to Youth Justice, work experience within the field, and an opportunity for further financial assistance.

#### **Mentorship**

As part of the program a Youth Justice officer, with relevant experience to the recipient's course of study, will provide support through the first year of the program. This mentor will assist the student in their studies and understanding of Youth Justice.

### **In the second year of the program**

#### **Graduate Program**

After successfully completing their course of study, the recipient will be appointed to a position within a Youth Justice Service Centre for up to one year. They will be upskilled in the various areas of Youth Justice to build capacity for secure permanent employment.

The areas of Youth Justice a program participant may rotate through include:

#### **Case management**

Delivery of culturally appropriate casework and counselling services that promote the safety and well being of young people with Youth Justice to assist in reducing offending behaviour.

#### **Restorative Justice**

An evidence-based approach to criminal behaviour, viewing crime as more than an act of breaking the law. It examines the impact upon society; the harm caused to the victim, family relationships and the community



#### **Court**

The role of youth justice as a representative of DJAG in pre-court preparation, completion of reports, advice to other departments and presenting in court

#### **Programs**

Providing support and services to young people and their families including the development of programs and services that meet individual client needs

#### **Detention Centre**

The management, care and delivery of services and programs to young people in detention to assist their rehabilitation and reintegration into the community.
