**Entry Information for International Applicants** 





James Cook University's <u>Bachelor of Medicine</u>, <u>Bachelor of Surgery</u> (MBBS) is a 6-year undergraduate program. This degree equips students with the skills to make an impact, and prepares them to graduate with confidence to take on any challenge after undertaking placements in diverse communities.

## **Overview**

This program aims to produce graduates of the highest academic standards, who can progress to medical practice and to further studies in medical specialties. Graduates will be uniquely qualified in the fields of rural/remote and Indigenous health and tropical medicine.

Students are based in either Cairns or Townsville for the first three years of this course. Placements are undertaken in every year, including in rural areas. Students in Year 4 of the course will be based in Townsville or Cairns. The majority of students in Years 5 and 6 of the course will relocate to other teaching sites in Cairns, Mackay or Townsville.

Graduates are not guaranteed an internship place in Australia. Places are made available depending on vacancies as identified by Australian health authorities. In the final two years of enrolment, students wishing to remain in Australia may be required, at their own cost, to complete an English test for purposes of registration with the Medical Board of Australia. Students must also follow the advice provided by the Australian Government in relation to visa applications.

This course is accredited by the Australian Medical Council.

## **Submissions**

The Written JCU International Application Form must be submitted along with all other required documents on or prior to the closing date through a JCU Agent or online directly to JCU.

Applicants who apply via a JCU Agent are recommended to submit their completed application to their nominated agent at least one week prior to the deadline. The application closing date is 31 August 2024. Applications received after this date will NOT be accepted.

# **Selection process**

In 2025, JCU has approximately 40 places in the Bachelor of Medicine, Bachelor of Surgery course for international applicants.

Applicants will be evaluated based on the following elements:

- Academic performance in Year 12 studies and/or in tertiary studies
- Participation in an interview, demonstrating attributes suited to a career in medicine.

Candidates will be selected for interview on the basis of their academic results. Applicants will be contacted directly by email for invitation to interview. Instructions for the timing, and how to join this online meeting will be provided to the applicant by email. If an applicant has submitted an application through an agent, both the applicant and agent will be sent these emails. Applicants are responsible for ensuring they have a device and quality internet connection to participate in the interview.

**Important:** JCU does not use the University Clinical Aptitude Test (UCAT) or Graduate Medical School Admissions Test (GAMSAT) as part of this selection process.

#### **APPLICANTS IN YEAR 12 OR EQUIVALENT IN 2024**

Please provide official copies of your Year 12 certificate or equivalent.

Your School Principal/Vice-Principal/Guidance Officer or Director of Studies must complete a <u>Prediction of Academic Achievement</u> form for you and email to JCU at <u>internationaladmissions@jcu.edu.au</u> by 5pm (AEST) on 31 August 2024.

## **APPLICANTS WHO COMPLETED YEAR 12 PRIOR TO 2024**

Please provide official copies of your Year 12 certificate or equivalent. If you have also commenced or completed tertiary studies, please also include a certified copy of your academic record to date.

Your most recent grade point average (GPA) score will be given the most weight to assess your application, however your entire academic record will be considered when determining offers for places. For 2024, a GPA of 5.75 on a 7 point scale was required to be considered for an interview.

Study or qualifications that do not generate a GPA score will not be considered, including study below AQF level 7 bachelor level or equivalent.



## **UNSUCCESSFUL APPLICANTS**

Applicants who are unsuccessful will be notified.

The number of places available to study medicine at JCU is limited. If your application is not successful, you may like to consider studying a Bachelor degree in Biomedical Sciences, Nursing Science, Pharmacy, Physiotherapy, Speech Pathology or Occupational Therapy. Strong academic performance may provide an opportunity for you to transition into Medicine, however this cannot be guaranteed.

#### **REQUESTS FOR FEEDBACK**

With an annual average of 400 applications to study medicine, JCU is not able to provide individuals with information or feedback about their application. This includes information relating to an individual's application form or written application.

Applicants who have been unsuccessful in obtaining a place in this course may choose to appeal the decision through a <u>Formal Review</u> within the timelines set in the <u>Student Review</u> and <u>Appeals Policy</u>.

# **English language requirements**

Some studies completed in Australia, Canada, Ireland, New Zealand, South Africa, UK or USA may meet the English Proficiency requirement.

#### **ENGLISH LANGUAGE TEST MINIMUM SCORES**

**IELTS (academic module)** with a minimum overall score of 7 and a minimum score of 7 in three of the components and 6.5 in one component (listening, reading, writing and speaking) in one sitting.

*or* **PTE Academic** with a minimum overall score of 65 and a minimum score of 65 in three of the four communicative skills (listening, reading, writing and speaking) and 58 in one component.

or TOEFL (internet based) with a minimum total score of 94 (23 in speaking, 24 in listening and reading and 27 in writing).

Near the end of their studies, international JCU Medicine students may be required, at their own cost, to complete an English test for the purposes of registration with the Medical Board of Australia. # Inherent requirements and adjustments

## International student visas

# **Professional experience placement**

Professional experience placement is a formal component of this course and prepares you for registration and/or accreditation as a professional in your field.

Students must meet all requirements for placements by the deadlines specified and maintain currency of all requirements to remain enrolled in this course.

## **Vaccinations**

Students must provide evidence of being immune to hepatitis B and that they have been vaccinated or evidence that they are not susceptible for the vaccine preventable diseases (VPD) of measles, mumps and rubella, varicella and pertussis.

Professional experience placement is a requirement of this course and students may be engaged in roles where there is contact that would allow transmission of a VPD. Students are required to comply with the above requirement prior to commencing their first Professional Experience Placement or by the end of the first teaching period of their studies (or whichever is sooner), otherwise their enrolment will be terminated.

JCU recommends additional vaccinations and students will receive information regarding these vaccinations at the commencement of their first year.

# Working with children

Queensland law contains provisions designed to ensure that persons who are to work with children and young people are first assessed on their known police and disciplinary information. The <a href="Working with Children Check">Working with Children Check</a> is a screening process that assesses your suitability to work with children and young people. A person whose application is approved will be issued with a Blue Card.

Requirements for course completion include conditions for students to undertake placements, which involve coming into contact with young people. Initial enrolment and continuing enrolment in this course are conditional upon the following:

- I. Eligibility of the student for a Blue Card at the time of first enrolment;
- Maintenance of that eligibility throughout the duration of the course;
  and
- III. Actual acquisition of a Blue Card prior to commencement of placement.

In the event that a student becomes ineligible for a Blue Card, at any time between the date of first enrolment and the date of completion of the course, the student's enrolment in the course may be terminated. Therefore, persons who have reason to believe that they might have difficulty in obtaining a Blue Card should clarify their position in that regard before deciding to apply for this course.

# Federal police check

All students are required to obtain an Australian Federal Police National Criminal History Check. International students are also required to complete a Commonwealth Statutory Declaration, which can be done once in Australia.
