Professional practice:

This course includes prescribed professional placements. Students may be required to undertake such placements away from the campus at which they are enrolled, at their own expense.

InPlace must be completed before the cut-off date in the designated week – [refer to calendar](#).

For embedded Professional Experience: successful completion of Placement and coursework (and associated assessment) is required to pass the subject overall. All subject requirements must be completed in the same study period in which you are enrolled. If you are repeating a subject with embedded Professional Experience, you must reattempt all subject requirements (i.e., practicum completed in a previous enrolment does not count).

Out Of Step Students: It is your responsibility to email dtesplacements@jcu.edu.au at the **commencement of the study period prior to enrolling** in the subject to request a placement. Failure to do so will mean that a placement will not be found.

Suitability to Work with Children Card ([Blue Card](#)):

This course includes prescribed professional placements that may involve contact with children under 18 years of age. Students are required to obtain a Suitability to Work with Children Card (which involves a criminal history check undertaken by the Queensland Police) before the start of the first placement in an Australian school setting. Students undertaking professional placements in Australian school settings must retain a current Suitability to Work with Children Card for the duration of their course, as failure to do so will result in the termination of their admission to the course.
