

INFORMATION AND APPLICATION FORM –SECOND YEAR STUDENTS

Education in the College of the Arts, Society and Education (James Cook University) acknowledges the high quality teaching and learning that takes place in rural and remote schools throughout Queensland and is committed to graduating pre-service teachers who are well prepared to work in these sites and their broader communities.

Education is offering “*Improving the Practicum: Focusing on Rural/Remote Professional Experience*” Travel Support Grants to assist highly motivated pre-service teachers to undertake a professional experience in a rural or remote Queensland school.

Through this initiative, pre-service teachers will be provided with financial assistance to enable them to build upon their knowledge, skills and professional teaching experience in rural or remote locations.

Up to TEN (10) grants will be awarded per annum

Second Year pre-service teacher grant recipients will be provided with a grant payment of \$500 to assist with travel and accommodation expenses

Applicants must complete the application form **in full** and provide **all** specified supporting documentation by the closing date to be eligible for consideration.

**Applications for Second Year Preservice Teachers close
9am Monday 29 May 2017**

Grant recipients must undertake a professional experience placement, as scheduled per Education Professional Experience Calendar, in a rural or remote school in 2017 – that is, the year in which the grant is approved.

Applicants seeking to undertake a professional experience placement in an Indigenous community will be looked upon favourably.

Applications will be reviewed by a panel that shall comprise, for example:

- the Head of Academic Group
- the Director of Professional Experience and Community Engagement
- the College Manager; and a
- member(s) of the Professional Experience Advisory Committee (Townsville and/or Cairns).

Pre-service teachers who are the recipients, in 2017, of any other form of financial assistance relating to professional experience (for example, Beyond the Range Professional Experience Grants, Rural and Remote Education Access Program [RREAP] funding) are **not** eligible to apply for “*Improving the Practicum: Focusing on Rural/Remote Professional Experience*” Travel Support Grants in 2017.

ELIGIBILITY CRITERIA

To be eligible for *“Improving the Practicum: Focusing on Rural/Remote Professional Experience”* Travel Support Grant, applicants must:

- be undertaking, full-time at James Cook University in 2017: *the second year of an undergraduate pre-service teacher education program*;
- be planning to undertake a professional experience placement in a rural or remote school and have indicated this on their professional experience placement request (as submitted by the due date) in 2017;
- be undertaking a professional experience placement in a school that is **at least 200 kilometres** from their primary residence;
- hold a current Blue Card from the Public Safety Business Agency.

PAYMENT OF GRANTS FUNDS

Grant payments will be paid direct to the successful applicant after confirmation of an eligible professional experience placement is provided. The successful applicant will be required to provide full bank account details in order for the grant payment to be processed.

The grant funds are to be used to assist with travel expenses related to their rural and remote professional experience placement, such as travel and accommodation.

Grant recipients are encouraged to seek independent financial advice regarding taxation matters and self-education expenses. Information about the taxation on scholarships and grants is available from the ATO Website at: <https://www.ato.gov.au/Calculators-and-tools/Is-my-scholarship-taxable/>.

Grant Recipients who withdraw from the pre-service teacher education program or their rural or remote professional experience after payment of the grant, **will** be required to reimburse the *“Improving the Practicum: Focusing on Rural/Remote Professional Experience”* Travel Support Grant funds.

APPLICATION PROCESS

All applicants must submit a written application by the closing date (and time), including:

- completed *“Improving the Practicum: Focusing on Rural/Remote Professional Experience”* Travel Support Grant Application Form **and**
- written responses to the following questions:
 1. What subjects have you undertaken and/or experiences have you had which would assist you in teaching in a rural or remote, or Indigenous, community? (Maximum 300 words).
 2. What strengths (i.e., knowledge, skills and attributes) do you believe you would bring to teaching in a rural or remote, or Indigenous, school and community? (Maximum 300 words).
 3. What do you think will be your greatest challenges as a pre-service teacher in a rural or remote school and community? (Maximum 300 words).

SELECTION PROCESS

Education (James Cook University) will offer grants through a merit selection basis determined by the written application.

GRANT OFFERS

Once the selection process is complete, successful applicants will be provided with a written notification – via email – of their successful application. Applicants will be required to respond in writing – via email – to the offer within a specified period of time. Upon receipt of the response to the grant offer, successful applicants will be forwarded a Bank Account details proforma for completion and submission within the specified period of time.

All grant offers are subject to the recipient providing confirmation of ongoing full-time enrolment in the Bachelor of Education program at James Cook University and confirmation of a professional experience placement in a rural or remote school.

Grant offers will be for a specific period during the 2017 calendar year only, and **cannot** be deferred.
