Bill Tweddell was elected as Chancellor for a five-year term, beginning on 26 March 2016. He is the University's fifth Chancellor, and the first JCU alumnus to be elected to the role. In 2010, Mr Tweddell was recognised as one of JCU's Outstanding Alumni. Mr Tweddell enjoyed a distinguished career in Australia's diplomatic service spanning four decades. Mr Tweddell was a senior career officer with the Department of Foreign Affairs and Trade. Most recently he served as Australia's Ambassador to the Philippines from January 2012 to January 2016. He previously served as Head of the Americas and Africa Division of the Department in Canberra, as Australian Ambassador to Vietnam, Deputy High Commissioner in the United Kingdom, Consul-General in Hong Kong and Macau, High Commissioner to Sri Lanka and the Maldives, and Deputy High Commissioner in India, with earlier postings to Greece and Bangladesh. He was also Chief of Staff to the former Minister for Foreign Affairs, Alexander Downer.

Professor Stephen Naylor has been an active participant in education, learning & teaching and the creative arts for more than 35 years. He has worked in high schools, TAFE and for the last 20 years worked in the University sector, receiving a National Carrick Institute Citation for Outstanding Contributions to Student Learning in Higher Education in 2007. He has assumed roles of leadership in each sector, driving curriculum, quality assurance, policy development, staff management, professional development, assessment strategies and research agendas. Currently he is Chair of the Academic Board of James Cook University (JCU) and serves on the Panel of Experts for TEQSA Australia.

His creative arts background drove his professional practice for more than 20 years and has seen him as an active arts reviewer for a variety of Australian journals. More recently his research has focused upon design and the understanding of a sense of place within the tropical region. He is currently preparing for a new Routledge monograph entitled *The Venice Biennale and the Asia-Pacific in the Global Art World*, due May 2019.

In parallel to his work in the creative arts he has maintained a strong link with pedagogy in higher education. With four years' experience in Asia, where he was the Dean for JCU's Singapore campus, he had a major role in providing commentary and advice at numerous forums throughout the region on assessment, student centric learning and teaching approaches and on quality assurance and academic governance in higher education. He has worked on a number of Boards and on the Panel of Experts for TEQSA.

Whilst undertaking roles in senior management he supervisors HDR candidates and is a PhD examiner for post graduate candidates in the broad areas of the creative arts at the intersection between business and teaching & learning.

Marjorie Pagani has been appointed by the Governor-in-Council for a four-year term from May 2018. Marjorie is Chief Executive Officer and a Director of the charity Angel Flight Australia, having helped to set up the charity as an aviation lawyer and volunteer pilot, in 2003: she holds a commercial pilot licence with instrument rating and twin-engine endorsement, and flies her own aircraft (having previously owned and managed an air charter and road-train business in Townsville). She was a presiding member of the Qld Anti-Discrimination Tribunal for 13 years, the Queensland Mental Health Review Tribunal for 8 years, and a member, then president, of the former North Qld Parole Board (Townsville) for 7 years. Concurrently with these roles and her Bar practice, she was also a director of the Townsville Port Authority, and served with the RAAF for 17 years as a Squadron Leader in the specialist legal corps reserve. Marjorie has a close connection with JCU, having graduated with Honours majoring in history and politics, and then lecturing in law, (graduating in that discipline from QUT), before going to the private Bar. She assisted the late Marylyn Mayo in successfully lobbying for a JCU department of law; was a co-founder of the Women's Legal Service in Townsville; and was granted the inaugural JCU Law Society life membership, in 1992. Marjorie is also founder and Managing Director of AFARM, a farm-animal rescue charity, based on the Atherton Tablelands.

Marjorie lives in on her farm in Tolga on the Atherton Tablelands west of Cairns, with her husband (a chief pilot and Angel Flight volunteer), where she runs a farm-animal rescue program. She has three sons and six grandchildren, and flies down to the Brisbane office of Angel Flight each week.

MS ANGELA TOPPIN

Angela Toppin, is currently Councilor, Mareeba Shire Council and retired IN 2016 as Principal, Cairns State High School in Far North Qld. She was a Business Teacher for 14 years at Mareeba State High School and was appointed Head of Department Business and Technology at Smithfield State High School in 1990. During that time she was able to 'drive' many innovations in the area of Business Education. She and her Team of very competent teachers were able to offer a very 'dynamic' curriculum which attracted enrolments from many other schools in the Cairns area. During this time she was President of the Peninsula Branch of BEAQ. During her presidency Angela focused very heavily on professional development for Business Educators and collegial support. It was an extremely active branch and very highly regarded by Principals' and Executive Officers of Education Qld.

1993 – Appointed Project Officer for Women in Management Project for Peninsula Region. During this time Angela developed a Regional Plan for women aspiring to leadership positions in educational leadership. Established a very successful Association of Women Educators in Peninsula Region, which she chaired for six consecutive years.

1994 – Appointed Deputy Principal at Mareeba State High School and 'spearheaded' VET in Schools

In 1997 her daughter was diagnosed with the death threatening – meningococcal septicemia, which caused her to re-evaluate her career direction for several years.

1998 – Acting Principal, Dimbulah P – 10 School. Focused on community engagement.

2000 – Acting Principal Atherton State High School and then appointed Principal at Malanda State High School. 2003 Appointed Principal, Mareeba SHS.

2011 – Appointed Principal Cairns State High School

Throughout her Principalship, Angela focused very heavily on community engagement with her School Community and in so doing has improved outcomes for her students in a variety of ways.

Her passion for education has seen her lead a very large school with enrolments of 1650 – Cairns State High School. A very complex school which offered a variety of unique Programs of Excellence and the International Baccalaureate, as well as maintaining International Accreditation through the Council of International Schools

In 1993 her 'passion' for rural students saw her initiate the Business Liaison Association in Cairns, which focuses on school industry links. With Angela's drive and passion, this Association now offers a wide range of programs to approximately 9000 – 10 000 students annually. She has remained Chairman of this Association and has ensured its sustainability so that young people in Far North Qld are 'given the opportunities' to experience unique programs' with business and industry.

In 1993 she was awarded Corporate Woman of the Year through the Cairns Businesswomen's Club. A unique honour for a passionate educator!

In 1995 she was awarded The Paul Harris Fellow, The Rotary Foundation of Rotary International, for her work with the Business Liaison Association and Association of Women Educators.

In 2009 she was awarded the prestigious Leadership in Profession Award by the Qld Secondary Principals' Association and was made a Fellow of the Business Educators Association of Qld for her long term dedication to Business Education in Qld. She was also awarded a Rotary International Pride of Workmanship Award for her leadership of Mareeba SHS.

In 2010, The Cairns Post listed her as one of the Most Influential Woman in FNQ (Number 12).

In June 2016 Angela was awarded the very prestigious Lifetime Achievement Award by the Qld Secondary Principals' Association in Brisbane by Director General of DETE, Dr Jim Watterston. The Award is in recognition of the significant contribution Angela has made to state education, and the work of Qld Secondary Principals' Association over an extended period of time The Award honours and recognises the great contribution Angela has made to education throughout her professional career.

Recently appointed as a member of the James Cook University Council.

Angela Toppin sees herself as 'Someone who makes a difference for young people'. She continues to mentor and coach young people in leadership positions and is very passionate about expanding opportunities for students in rural and regional areas. He was previously a Judge Advocate and Defence Force Magistrate prior to his appointment to the District Court. His Honour was also a part time tutor in law at James Cook University (1997-2000).
