ADDITIONAL COURSE RULES

A maximum of 30 credit points may be taken at level 1 A minimum of 18 credit points must be taken at level 2 A minimum of 18 credit points must be taken at level 3

COURSE PROGRESSION REQUISITES

Must successfully complete 12 credit points at level 1 before attempting any level 3 subject.
