### SUBMISSION AND PUBLICATION AGREEMENT

#### Introduction

Manuscripts will not be considered for publication until a signed copy of this Agreement has been received. No amendment shall be made to this agreement without the express consent of the Editors.

### **Authorship**

The *James Cook University Law Review* operates under the assumption that you are the original author (or co-author) and the owner (or co-owner) of the copyright in the manuscript. In signing this Agreement, you warrant that:

- the manuscript is an original work created solely by you (and if relevant, co-authors) and that no part of the manuscript violates any copyright;
- if you refer to material not created solely by you, such material is properly attributed to its respective authors;
- the manuscript as a whole has not been published elsewhere. If parts of the manuscript have been published elsewhere, they are referenced accordingly;
- no part of the manuscript has been submitted for publication elsewhere, or will be submitted for publication elsewhere, until the Editors confirm in writing that they do not intend to publish the manuscript in the *James Cook University Law Review*;
- the manuscript is not defamatory;
- if you are a co-author, you have been authorised by all co-authors to sign this agreement on their behalf; and
- the manuscript does not infringe the rights of any third party.

You agree to indemnify the *James Cook University Law Review* and its Editors for any loss or damage arising from the breach of any of these warranties or for any other liability that may arise in connection with the publication or reproduction of your manuscript.

# Review of your manuscript

Upon submission, your manuscript will be considered by the Editors and, if appropriate, peer reviewed. The Editors reserve their right not to proceed with publication of your manuscript in the *James Cook University Law Review* for whatever reason. You agree that the Editors' decision on

whether to publish your manuscript is final. You should not treat any communication from the Editors during the review period as an undertaking to publish your manuscript. Alternatively, as the application process may be slowed by the sending of manuscripts to external reviewers, any delay should not be treated as non-acceptance of the manuscript.

The Editors retain the right to edit your manuscript to correct any spelling or syntax errors, to conform to style requirements and/or to enhance expressions or clarify meaning. In signing this Agreement, you authorise the Editors to do so without obtaining prior approval. The Editors will, however, normally consult the author(s) prior to making any major changes.

## Your copyright

Copyright in the manuscript remains with you. In signing this agreement, you grant the *James Cook University Law Review* a world-wide, non-exclusive, royalty-free, perpetual, irrevocable licence to publish and reproduce your article and to grant third parties the right to do so on the terms and conditions stated below.

### Further publication and reproduction

The Editors encourage national and international dissemination of articles published in the *James Cook University Law Review* by publishing in a variety of other formats which may include: the Internet, CDs, online databases operated by third parties (for example the Australian Legal Information Institute (Austlii), Informit, HeinOnline) and any future technology. In signing this Agreement you authorise the Editors and therefore third parties to publish your manuscript in any of these formats as the Editors deem appropriate without any remuneration to the author.
