

Scholarship Rules 2023

(JCU Year 12 Rising Star Scholarship)

Introduction

The purpose of the JCU Year 12 Rising Star Scholarship is to support students who have demonstrated consistently high levels of academic achievement and personal attributes that uphold and champion their school's ethos. This scholarship helps the regions best and brightest to learn, train and advance the economic and social fabric of North Queensland communities.

This bursary is subject to the provisions of James Cook University's [Coursework Scholarships, Bursaries and Grants Policy](#).

Value and payment of the Scholarship

The value of the scholarship is \$10,000 to be paid over three years as per below:

Year 1 – \$4,000

Year 2 – \$4,000

Year 3 – \$2,000

The scholarship will be paid in two equal instalments each year, after the census dates of Study Period 1 and Study Period 2. Please allow up to 6 weeks after census date for payment.

Up to 45 Scholarships will be awarded each year, discontinuation of this scholarship will be advised from Future Students.

Eligibility Criteria

1. The JCU Year 12 Rising Star Scholarship will be open to competition among candidates who:
 - 1.1. are domestic students, i.e. Australian citizens, New Zealand citizens and holders of a permanent visa; and
 - 1.2. have selected or will select an eligible JCU course as their first preference through the Queensland Tertiary Admissions Centre (QTAC); and
 - 1.3. have demonstrated actions and behaviour that exemplifies the school's ethos; and
 - 1.4. will be enrolled full-time (9 credit points)

An eligible JCU course is all undergraduate Bachelor and joint degrees offered by JCU at the Townsville and Cairns campuses, excluding the Bachelor of Medicine, Bachelor of Surgery, the Bachelor of Dental Surgery and the Bachelor of veterinary Sciences.

Selection Criteria

2. The JCU partner schools are to determine the recipient from their school based on the eligibility criteria outlined above.

Application Requirements

3. All JCU partner schools are to nominate one recipient to receive the scholarship, via the online nomination form. This will be formally announced at the end of year School's Presentation Ceremony or similar event.

Selection Process

4. The JCU partner school is to determine the process of selecting the appropriate scholarship recipient under the eligibility criteria.

Ongoing eligibility

5. The recipient must maintain a full time enrolment.
6. The recipient must maintain a course GPA of 5 or above.

If the holder of the award does not meet the continuing eligibility as specified the student can submit a statement of reasons to be considered by the Manager of Future Students and the Manager of Student Finance and Examinations.

Conditions of the Scholarship

7. If the recipients does not accept their offer to study at James Cook University they will no longer be eligible for the award.
8. If the recipient does not enrol full-time in subjects in Teaching Period 1 they will no longer be eligible for the award.
9. If the recipient defers their study, the recipient will no longer be eligible for the award.
10. If the holder of the award does not maintain a fulltime load of the award will be terminated.
11. If the holder of the award does not meet the other continuing eligibility as specified above, the student can submit a statement of reasons to be considered by the Manager of Future Students and the Manager of Student Finance and Examinations.
12. A student may lodge a request for review of decision in accordance with the provisions of the Student Review and Appeals Policy and Procedures. <https://www.jcu.edu.au/policy/student-services/student-appeals-policy>

Administration of the Scholarship – Section 9

13. The scholarship shall be administered by the Scholarships Office, on behalf of the Owning Organisation Unit.
14. The funds of the scholarship shall be held in an account in the name of the University and shall be administered by Scholarships Office.

15. Where an award provides some benefit to the recipient from a body external to the University, or an obligation upon a body external to the University, the University, its servants and agents, shall not be liable for that benefit or obligation.
